## APPLICATION FOR AUTHENTICATION OF AN EXISTING SOLID FUEL BURNER

I/we wish to apply for authentication of the SMALL SCALE SOLID FUEL BURNING APPLIANCE under A2-55 of the Nelson Air Quality Plan, to authenticate whether it has a date of installation prior to 23 August 2003 and to provide an opinion as to whether the fire is an operable unit, in terms of the definition in A2-63A of the Nelson Air Quality Plan.

**METHOD** of authentication requested, pursuant to A2-55 (d) *(Please tick as appropriate)*

- (i) Valuation report or sale and purchase agreement dated prior to 23 August 2003, showing burner as a chattel
- (ii) Original invoice of the burner's installation
- (iii) Copy of the installer's office record (certified by a Justice of the Peace)
- (iv) Authentication report from a person authorised by the Council (fee payable of \$70)

It is acknowledged that, as no records of the current small scale burner exist on Nelson City Council records, there is a need to establish the fire as **lawfully approved** in order for the appliance to be able to be replaced under the Nelson Air Quality Plan. If authentication is obtained, and if it is intended to replace the above appliance with a Nelson City Council authorised burner, a Building Consent will need to be lodged before the phase out date applicable to the Airshed in which the property is located and installation date of the existing woodburner (AQR.1 cc)
