Conditions for the Use of Parking Permits and Parking Signs

Under the provisions of Nelson City Bylaw 207/2004 authorisation may be granted for the use of permits and no stopping signs. Any permit used without permission may be removed without prior notice.

- A. Permits/ signs issued shall be for the vehicle(s). Location and purpose as specified on this form.
- B. Permits/signs shall only be issued for goods service vehicles, trucks and trailers necessary to service construction and/or maintenance work being carried out on the road or adjacent property where it is essential that such vehicles be immediately available during the course of that work.
- C. The maximum term of issue is 1 month unless authorised by the Manager Parking.
- D. The person to whom the sign(s) are issued is responsible for the proper placing, care and return of the sign(s). In the event of damage, loss (or theft) of any sign a replacement charge of \$80.00 (GST inc) shall be made in addition to all fees due to that date the loss is reported to the council, phone 546 0278.
- E. The Manager Parking:
 - i. Retains the right to reclaim any sign or cancel any permit found being used in contravention of the above conditions.
 - ii. May refuse to issue permits/sign(s) to individuals, organisations, groups or companies who have on previous occasions used a permit/sign in contravention of the above conditions.
 - iii. May refuse to issue permits/sign(s) for those areas where in her/his opinion, the issue of further permits/sign(s) would reduce the number of parking spaces available to the public in that area to an unreasonable level.
 - iv. Reserves the right to suspend the issue of permits/sign(s) during the period 15 December to 15 January to ensure the availability of parking spaces during the pre-Christmas shopping period and busy holiday period.
- F. The Council reserves the right to change conditions and/or charges. One month's notice of any changes will be given.
- G. Permits/sign(s) issued before 330pm shall be charged for a full day for the date of issue. Sign(s) returned after 930am on days subsequent to the date of issue shall be charged for a full day of the date of return.
- H. Maximum permits per site /area, should not exceed 3.

When a permit/sign(s) is used in a space controlled by a meter in compliance with the above conditions, the parking bylaw no longer applies. The obligation to pay at the meter and to comply with the time restrictions for that area is removed. Restrictions which prohibit parking at specified hours shall be observed. **This form must be displayed to validate the parking permit.**
